Added Comments: The source of funds for the augmentation will be provided by unanticipated revenues and beginning fund balance.

#### **BACKGROUND:**

The augmentation procedure, as prescribed by NRS 354.598005, provides that an augmentation for a fund that receives no ad valorem taxes may be accomplished by a majority vote of the Board at a regular meeting. Attached is the Resolution to Augment the Stadium Authority Fund (2960) in the amount of \$11,759,007 for the Fiscal Year 2020-21.

The additional appropriations will be used for transfers out to other Stadium Authority funds.

An augmentation of appropriations is necessary to give the legal authorization to expend the additional resources. To complete the augmentation procedure, the attached Resolution to Augment the Fiscal Year 2020-21 Stadium Authority Fund (2960) must be adopted. Following adoption of the Resolution to Augment, the Resolution will be forwarded to the State of Nevada Department of Taxation.

#### RESOLUTION TO AUGMENT THE STADIUM AUTHORITY FUND (2960) CLARK COUNTY STADIUM AUTHORITY FOR THE FISCAL YEAR 2020-21

WHEREAS, the revenues, transfers in, and beginning fund balance of the Stadium Authority Fund (2960) for the Clark County Stadium Authority were budgeted to be \$17,948,675 on July 1, 2020; and

WHEREAS, the revenues, transfers in, and beginning fund balance in the Stadium Authority Fund (2960) are now determined to be \$29,707,682; and

WHEREAS, the source of funds for this augmentation will be provided by \$10,970,682 in unanticipated beginning fund balance and \$788,325 in unanticipated revenue earnings; and

WHEREAS, there is a need to apply these excess proceeds to the Stadium Authority Fund (2960); and

WHEREAS, the additional resources will be used for transfers out.

**NOW, THEREFORE, IT IS HEREBY RESOLVED**, that the Clark County Stadium Authority Board of Directors hereby augments its Fiscal Year 2020-21 budget by appropriating \$11,759,007 for use in the Stadium Authority Fund (2960), thereby increasing its appropriations, including transfers out from \$17,948,675 to \$29,707,682. A detailed schedule is attached to this Resolution and by reference is made a part hereof.

IT IS FURTHER RESOLVED, that the Stadium Authority forward the necessary documents to the State of Nevada Department of Taxation.
